Dear Chairman Begeman:

By letter to Mr. Ottensmeyer dated December 17, 2018, you requested The Kansas City Southern Railway Company ("KCSR") to disclose to the Board KCSR's quarterly revenues from demurrage and accessorial charges, stated separately for 2018 and 2019. You requested the 2018 information by January 21, 2019 and the 2019 date on a quarterly basis by the 15<sup>th</sup> day of the month following the end of the quarter.

On behalf of KCSR, by letter dated December 27, 2018, I wrote to you requesting minor extensions of the deadlines stated in your December 17<sup>th</sup> letter. The December 27<sup>th</sup> letter was a follow up to my communications with OPAGAC Director Lucille Marvin on this subject. Due to the partial government shut-down, I realize that you have not yet had an opportunity to officially respond to my December 27<sup>th</sup> letter, although I am assuming that KCSR's requests contained within that letter were approved.

Consistent with your December 17<sup>th</sup> request, as modified by the dates contained within my December 27<sup>th</sup> letter, KCSR hereby provides the Board with the requested information for 2018 (see attached). KCSR will provide the 2019 data via quarterly submissions on April 30, July 30, October 30, 2019, and January 30, 2020.

As the information request came from you, KCSR is hereby responding directly to you. However, for future quarterly filings, if you would like KCSR to e-file them or to email them to a particular person other than you, please let me know.
